#### **Tuition**

- You are committing to a 10-month Contract - There are no refunds or no credits. **You will be held responsible for full payment from September 2025 until June 2026.**
- Tuition is due the first class of every month. A \$10 late fee will be applied to those who hand in their tuition after the 10th of each month (no exceptions).
- There is a \$35 charge for all bounced checks. If you bounce a check, you will be asked to pay in cash for the remainder of your time at Diva Dance.
- Monthly tuition is based on a yearly cost, divided into equal monthly payments. Each monthly payment is the same whether there are 3, 4, or 5 classes that month. If tuition is not paid, your child will not be allowed in class. Tuition payments must be made in cash or check only.
- We do not prorate tuition. If your child is absent, yet classes are still held, you will still be responsible for paying your monthly tuition.

#### **Class Attendance & Attire**

- No make-up classes are available unless we close for inclement weather. We follow the NYC DOE calendar.
- Classes cannot be switched after December 1st.
- **All students must participate in the recital, no exceptions!**
- Attendance is very important. Please do not miss more than (3) classes. This will help teach your children about commitment.
- Students are to be dressed in proper dance attire with hair pulled up and neat. No street shoes are to be worn in the dance rooms. No gum chewing is permitted in the studio.

#### **Behavior**

- There is absolutely no eating allowed anywhere in the studio, unless designated by staff.
- All strollers, carriages, bicycles/scooters are to be left outside. We are not responsible for any items left outside. No pets allowed inside the studio, unless it's a certified service animal.
- Diva Dance cannot and will not be held responsible for any injuries sustained on the premises.

### **Costumes & Recital**

- All students enrolled must participate in the end of year recital and purchase the recital costumes. Costume payments will be due in November 2025. The exact date will be emailed at a later date.
- Cash is the only acceptable form of payment for costumes. A \$35 late fee will apply if costumes are not paid by the due date.
- We are not able to issue refunds for costumes.
- The recital will take place in June 2026 at an off-site location to be announced at a later date.
- A mandatory recital fee will be due in May 2026. The approximate cost is \$50-\$100 per dancer. The exact amount will be emailed at a later date.
- No costumes or tickets will be issued to any dancer with an outstanding balance.
- If you lose your recital tickets, you must purchase new ones.
- We are not able to provide anyone with our Tax TD#.
